Advisory Services: The objective is to support more companies in designing and developing their own customized, high-impact pro bono services to increase the volunteer base and pro bono movement to further improve society. In 2017, Advisory Services supported the delivery of 24,744 hours of corporate pro bono service, totaling \$3,711,600 in value for 289 nonprofit clients.

Speed Consulting and Pro Bono Marathons. These are Done-in-a-Day events where nonprofit participants are paired with pro bono consultants for a day or half-day for the purpose of consultation or to tackle a scoped project. Speed Consulting connects nonprofits with pro bono consultants for a half-day, round-robin workshop to gather advice on a few key challenges across multiple areas. Pro Bono Marathons team nonprofits with 2 or 3 pro bono consultants to address a critical challenge from scope to deliverable in one day.

Service Grants or Team-Based Projects pair nonprofits with a team of 4 - 6 pro bono consultants for a 12 -15 week project fully customized to address the organization's most pressing infrastructure challenge.
